Welcome to the meeting: President, Karen Bamford

Brian and Jackie Enman were welcomed to the meeting. Brian is retiring as Pro at Bangor Municipal Golf Course this year. Marilyn Rice spoke of Brian's achievements in golf competitions and as Pro at various courses. Other BWGC members told of their fond memories of working with Brian. He will be missed by us all.

Reports:

1. Secretary's Report

The bullets of the secretary's report of the September 3, 2015 BWGC Monthly Meeting were read.

2. Treasurer's Report

The beginning checkbook balance was \$2,447.12. The ending balance was \$1,723.81. The treasurer's report can be found in the Meeting Minutes notebook in the locker room.

3. Tournament Chair Report

Karen thanked Claudette Amoroso and Vi Kemp for the fine job they did planning tournament events for the year.

Claudette reported that next year the Solheim Cup will be scheduled earlier in the season so that teachers who are members of BWGC can be included in this event.

Ideas were shared for how to eliminate tournaments on Wednesday. Claudette suggested that we have 2 away tournaments on Thursday instead of playing on Wednesday. It was suggested that we go to Lucerne Golf Club twice instead of just once, or we could go to Traditions for one tournament.

Another suggestion was that where one tournament doesn't begin until 1:00 PM, we might have our tournament begin at 7:30 A.M. That would eliminate another Wednesday.

Another suggestion was using the Kelly Nine course and having tee times.

One other suggestion was that we try Night Golf for one of our tournaments.

Claudette urged us to think about this over the winter and address the issue again at the Spring Meeting.

4. Handicapper Report

Jean Young announced that she would no longer be handicapper.

There has been some confusion about how to post scores. All regular tournaments should be posted as **HOME** scores. **President's Cup** and **Club Championship** scores should be posted as **TOURNAMENT** scores. **WMSGA** regular scores should also be posted as **HOME** scores. Special tournaments, such as the Janet Druin Tournament should be posted as **TOURNAMENT** scores. Only use **AWAY** scores when you are playing at a course, such as Waterville, when you are playing on your own; not playing with WMSGA or BWGC

WMSGA: Jean will be our WMSGA Representative next year.

There will be a WMSGA tournament at Bangor Municipal Golf Course in early June of 2016.

Jean again mentioned that Staci Creech was the winner of the Women's State Amateur Golf Tournament in 2015. This tournament will be held in 2016 at Penobscot Valley Country Club, and in 2017 it will be held in the southern part of the state.

The possibility of having the Women's State Amateur at Bangor Municipal Golf Course was discussed. It was decided that it would be left to the BWGC Executive Committee to decide whether or not they wanted to ask WMSGA/SMWGA to consider Bangor Municipal Golf Course as being the host of the Women's State Amateur Golf sometime in the near future.

5. Three-putt Jar Report

Judy Richard announced that \$209.00 was collected in the three-putt jar. She thanked us for contributing. Prior to the evening supper, raffle tickets were sold for a basket of goods that Louise Shindler assured us everyone in the room would want and/or need. \$149.00 was collected. The amount from the three-putt jar and the raffle ticket sale will be matched by funds from our treasury. The total amount will be given to Spruce Run.

Janice White made the motion that this proposal be accepted as stated. Kathy Anderson seconded the motion. There was discussion about this matter. A vote was taken. The majority of members present voted that the proposal be approved.

Proposal number 2: This year BWGC will give Brian Enman \$200.00, Chuck Shepley \$100.00, and Rob Jarvis \$50.00.

Janice white made the motion that this proposal be defeated. Louise seconded it. The proposal was defeated. Discussion ensued concerning what amounts of money participants wanted BWGC to give to Brian, Chuck and Bob.

Janice White made the motion that Brian be given \$200.00, Rob Jarvis \$75.00, and Chuck Shepley 75.00. Liz Coffin seconded the motion.

The vote was unanimously in favor of the motion.

Proposal number 3: Our qualified handicapper should be involved in doing the pairings for major tournaments.
